1. Holding of the Corporation's Annual Stockholders' Meeting ("ASM") on December 17, 2025 at 2:00 p.m. through remote communication/online (Zoom). The record date is set on November 25, 2025. The other details of the ASM shall be announced at a later date.

2. As last approved on November 8, 2024, amendment to Article Seventh of the Corporation's Amended Articles of Incorporation to reflect the decrease in authorized capital stock, such that the changes are as follows:

SEVENTH	That the authorized capital stock of the Corporation is TWO HUNDRED FIFTY MILLION PESOS (P250,000,000.00), Philippine Currency, and said authorized capital stock is divided into TWO BILLION FIVE HUNDRED MILLION (2,500,000,000) shares at par value of TEN CENTAVOS (P0.10) per share.	That the authorized capital stock of the Corporation is <u>TWO HUNDRED THIRTY SIX MILLION NINE HUNDRED SIXTY EIGHT THOUSAND FOUR HUNDRED SIXTY ONE PESOS AND NINETY CENTAVOS (P236,968,461.90)</u> , Philippine Currency, and said authorized capital stock is divided into <u>TWO BILLION THREE HUNDRED SIXTY NINE MILLION SIX HUNDRED EIGHTY FOUR THOUSAND SIX HUNDRED NINETEEN (2,369,684,619)</u> shares at par value of TEN CENTAVOS (P0.10) per share.
