Please be informed that **MILLENNIUM GLOBAL HOLDINGS, INC.** (the "Corporation" or "MG") received today from the Philippine Stock Exchange ("PSE") the denial of request for reconsideration of the imposition of penalties due to:

- a) Delayed disclosure of the correct shareholdings of its director, Ms. Yeh Hsiu Yin; and
- b) Inaccurate reporting of Ms. Yeh's shareholdings in the Corporation's Public Ownership Reports for the quarters ended December 31, 2021 up to September 30, 2022.

The Corporation explained that Ms. Yeh had apparently acquired 100,000 MG shares 9 years prior to becoming a director of MG. Upon learning thereof, the Corporation caused the immediate amendment of relevant reports to properly include the 100,000 initially undeclared MG shares of Ms. Yeh which she bought 9 years before her election as director.

Despite the explanation, the PSE imposed penalty of Php2,131,000.00, citing the above violations, payable within 10 calendar days from October 27, 2025. Failure to pay the same within 1 month from imposition will result in the suspension of the trading of the Corporation's shares.
